STORAGE CHARGE

- first 24 hours free of charge
- from second day 5 CZK per kilogram and day
- minimum charge 50 CZK
- storage charge is collected whenever a shipment is kept in the warehouse for reasons not caused by CSA

STORAGE IN THE WAREHOUSE VESTIBULE

- first 2 hours free of charge
- over 2 hours 10 CZK per kg and day
- CSA is not liable for any damage or loss

If the customer requires the carrier to divide the shipment into several parts and clear the parts separately, each part will be considered an individual shipment, in terms of the application of weight and extra charges.

SHIPMENT EXPRESS CLEARANCE

100% surcharge in addition to the basic handling charge

- Applicable to shipments delivered earlier than 180 minutes after the arrival of the flight. The extra charge does not apply to live animals, perishables, human remains, human organs, life-saving drugs and diplomatic mail.
- Extra charges do not apply to CSA Equation and Air France Equation, where they are already calculated in the carriage charge.

CC – “CHARGES COLLECT” SHIPMENTS

5% of the carriage charge,
min. 300 CZK

VALUABLES – VAL, VUN (guarding throughout transport from the aircraft to the warehouse, storage in a special warehouse)

1000 CZK per shipment

LIVE ANIMALS CLEARANCE – AVI (check of documents and packaging)
Does not apply to shipments stored at PVS

100% surcharge in addition to the basic handling charge

ATTENDANCE TO LIVE ANIMALS (watering and feeding)

100 CZK per shipment

EXTRA COSTS

(searching for and opening of a shipment upon the customer's request before the actual delivery, changing instructions, such as a change in the consignee's address, destination, etc.)

100 CZK per shipment

STORAGE CHARGE

First 3 days after advice dispatch

(Saturdays included, Sunday and public holidays excluded)

free of charge

From 4th day – see the storage charge calculation table.

Minimum charge

50 CZK

OTHER SERVICES

SHIPMENT ACCEPTANCE AND DELIVERY OUTSIDE OF WORKING HOURS 100% surcharge in addition to the basic handling charge

- The extra charge does not apply to live animals, perishables, human remains, human organs, life-saving drugs and diplomatic mail.

LIQUIDATION OF A SHIPMENT (uncollected goods – claims) actual costs, 600 CZK per shipment (incinerator) 1400 CZK per shipment and 10 CZK/kg + VAT
Note: the actual costs of ecologic liquidation by an external company are collected for the liquidation of dangerous goods.

LOADING/UNLOADING TO/FROM VEHICLE:
